

 HOW DO YOU WORK AN ACCOUNT? Accounts are worked by applying one

or more Smart Codes. Your management can set up the system to automatically date, close or notate accounts based on the Smart Codes you apply.

WHAT ARE SMART CODES?

Smart Codes are codes assigned by management to represent an action, event or a set of circumstances (e.g. Telephoned residence left message, debtor disputes account or debtor has an attorney).

The Smart Code window is displayed when a Smart Code is entered

Depending on the type of Smart code you will be able to enter information such as a follow-up date, promise amount, notes or a recall time.


